## APPEALS

### Appeal

An appeal is a **request to reconsider a decision** (or any conditions attached to a decision) made by a member of staff or other person acting on behalf of West Granton Housing Co-operative.

Tenants and other customers of the Co-operative may appeal against decisions.

Examples of decisions include:

- a decision on a request made by a tenant under the Tenancy Agreement (e.g. a request to assign a tenancy);
- a decision in relation to arrears action (e.g. the issue of a Notice of Proceedings);
- the rejection of an application for housing;
- the refusal of a request for a repair or adaptation;
- a decision to recharge a tenant for a repair;
- a decision to reject a membership application.

An appeal against a decision is not the same as a complaint and the provisions of WGHC's Complaints Handling Policy do not apply.

### How to appeal

You have the right to submit an appeal against decisions made by WGHC which affect you. The appeal will be considered by our Committee of Management. Your identity will not be disclosed to the committee. The Committee's decision will be final. Generally, there are 10 Committee of Management Meetings held each year. Appeals will be presented at the next available Committee of Management Meeting.

Appeals should be in writing and should say:

- What the decision was;
- the reasons for the appeal;
- What the desired outcome is.

You can use the form overleaf or write a letter.

We will not normally consider an appeal submitted more than 3 months after the date of the decision. We will not consider appeals which are vexatious, malicious or persistent.

The Chief Executive will write to inform you of the appeal decision.
